

Our analysis produced the following statistics, which we encourage you to verify before acting upon them. The image below shows a summary of the search results in Identity Finder DLP 5.0. Please see the explanation below for clarification and detail.




Explanation and Clarification of Statistics:

- Identity Finder found 112,014 uncompressed files containing personal information;
- 2,719 Social Security Numbers, of which 1,923 were unique;
- 8 Credit Card Numbers;
- 8,214 Passwords, of which 4,661 were unique;
- 57 Bank Account Numbers;
- 53 Drivers License Numbers;
- 15,798 Dates of Birth, of which 2,058 were unique;
- 106,691 Phone Numbers, of which 17,105 were unique;
- 48,182 Personal Postal Addresses, of which 7,165 were unique; and
- 1,531,638 non-unique e-mail addresses.

This exposure appears to affect law enforcement officials and individuals who have had interactions with law enforcement or participated in investigations. We hope that this report will aid the organizations compromised as they investigate what appears to be a breach of sensitive personal information.
